Health Care Access Expansions and Use of Veterans Affairs and Other Hospitals by Veterans

Dr. Jean Yoon, PhD, a Health Economist in the Veterans Affairs Health Economics Resource Center and Adjunct Professor at the University of California, San Francisco, used inpatient discharge data from the Pennsylvania Health Care Cost Containment Council (PHC4) to support her study of veterans' use of the US Department of Veterans Affairs (VA) and non-VA care. Dr. Yoon's study, Health Care Access Expansions and Use of Veterans Affairs and Other Hospitals by Veterans, examined six years of hospitalizations for Veterans in Pennsylvania and four other states. The research team examined data to understand the services used.


